#### What is a Pediatric SANE?

The Pediatric Sexual Assault Nurse Examiner (SANE) is a registered nurse who has been specially trained to care for the complex issues surrounding pediatric victims of sexual assault. The purpose of this training is to teach interested SANEs how to better care for their patients by recognizing, collecting and preserving evidence, interviewing victims and linking them to vital community resources for follow-up.

## **Course Description**

The purpose of this training is to provide nurses who have attended and completed all requirements of a basic Sexual Assault Nurse Examiners Training course with basic knowledge specific to pediatric forensic evaluation. This intense 5 day training will cover Pediatric Anatomy, Patterned Injuries, Forensic Photography, Congenital Anomalies, Mock Trial/Issues in Testimony, and Forensic Documentation.

This training does not "certify" the nurse to perform pediatric sexual assault exams. Satisfactory completion indicates that the nurse has attended the training. Post clinical requirements will be recommended and will be the responsibility of the nurse to arrange after the completion of the pediatric training.
